

Privacy Policy

- 1 These provisions (the "Privacy Policy") govern the use of <https://www.copper-panda.consulting> (the "Site") effective the headered date of this document. Purpose

- 4 The purpose of this Privacy Policy is to inform users of our Site of the following:
 - (a) The personal data we will collect;
 - (b) Use of collected data;
 - (c) Who has access to the data collected; and
 - (d) The rights of Site users.
- 5 This Privacy Policy applies in addition to the Terms and Conditions of our Site.

Consent

- 6 By using our Site users agree that they consent to:
 - (a) The conditions set out in this Privacy Policy; and
 - (b) The collection, use, and retention of the data listed in this Privacy Policy.

Personal Data We Collect

- 7 We only collect data that helps us achieve the purpose set out in this Privacy Policy and necessity to conduct routine or requested business. We will not collect any additional data beyond the data listed below without notifying you first.

Data Collected Automatically

- 8 When you visit and use our Site, we may automatically collect and store the following information:
 - (a) IP address;
 - (b) System information;
 - (c) Clicked links; and

- (d) Content viewed.

Data Collected in a Non-Automatic Way

9 We may also collect the following data when you perform certain functions on our Site:

- (a) Name;
- (b) Email address;
- (c) Phone number; and
- (d) Address.

10 This data may be collected using the following methods:

- (a) Customer-initiated forms and emails.

How We Use Personal Data

11 Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy. The data we collect automatically is used for the following purposes:

- (a) Anonymized statistical traffic and Site usage.

12 The data we collect when the user performs certain functions may be used for the following purposes:

- (a) Communication needs.

Who We Share Personal Data With

13 Employees: We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

14 Third Parties: We will not share user data with any third parties. Third parties will not be able to access user data beyond what is reasonably necessary to achieve the given purpose.

15 Other Disclosures: We will not sell or share your data with other third parties, except in the following cases:

- (a) If the law requires it;
- (b) If it is required for any legal proceeding;
- (c) To prove or protect our legal rights; and
- (d) To buyers or potential buyers of this company in the event that we seek to sell the company.

16 If you follow hyperlinks from our Site to another Site, please note that we are not responsible for and have no control over their privacy policies and practices.

How Long We Store Personal Data

17 User data will be stored for up to 10 years past final contact or need of business function. You will be notified if your data is kept for longer than this period.

How We Protect Your Personal Data

- 18 Information collected on this Site may be stored in an independent location either on-premises or on-cloud systems securely controlled by Copper Panda Consulting.
- 19 While we take all reasonable precautions to ensure that user data is secure and that users are protected, there always remains the risk of harm. The Internet as a whole can be insecure at times and therefore, we are unable to guarantee the security of user data beyond what is reasonably practical.

Children

- 20 We do not knowingly collect or use personal data from children under 13 years of age. If we learn that we have collected personal data from a child under 13 years of age, the personal data will be deleted as soon as possible. If a child under 13 years of age has provided us with personal data their parent or guardian may contact our privacy officer.

We do not track the users of our Site over time and across third party websites and therefore do not respond to browser-initiated DNT signals. We are not responsible for and cannot guarantee how any third parties who interact with our Site and your data will respond to DNT signals.
